This fund is managed by Danske Invest Management Company (Société Anonyme), part of the Danske Bank group.

Objectives and investment policy

Objectives

The objective of this fund is to generate a return which is higher than the return on the European stock market. The fund is accumulating.

Investment policy

The fund invests mainly in European equities (except Russian equities) listed on an official stock exchange. A minor part can be invested in equities in companies domiciled in countries bordering Europe. The equities are selected on the basis of specific expectations to the return of the individual equity.

The investment strategy is active. This means that we aim to find the best investments to generate the highest possible return with due consideration to risk. The strategy implies that the investments in the portfolio may deviate from the benchmark, and that returns can be either higher or lower than the benchmark.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The fund is categorized as 5. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

Charges


