Objectives and investment policy

Objectives

The objective of this fund is to seek capital growth in the long term through active investment management. The fund is accumulating.

Investment policy

The fund invests in a diversified portfolio of other funds mainly invested in equities and bonds in respect to the following allocation:

Between 40% and 100% will be invested in equity funds. Between 0% and 50% will be invested in bond and money market funds. Between 0% and 50% will be invested in hedge and absolute return funds. Max

30% of the assets may be invested in ETF's.

The allocation between bond, equity, hedge and absolute return investments can change over time.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 6 years.


