## Objectives and investment policy

## **Objectives**

The objective of this fund is to generate a positive return regardless of market conditions. Dividends are normally distributed to investors each spring.

#### Investment policy

The fund invests mainly in equities and equity related securities in companies domiciled in or with main activity in Europe. The fund can invest a small part in securities domiciled in or traded on regulated markets in countries outside Europe.

The risk management of the fund is an important part of the portfolio management. Ideally, the risk management contributes to both

minimizing the risk and improving the possibilities for a higher return. The risk is reduced by minimizing the sensitivity against movements in the equity market and by diversifying the investments on approx. 25-35 different strategies which typically consist of one long position and several short positions which will only be taken via financial derivative instruments.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.


