

**Objectives and investment policy**

**Objectives**

The objective of the fund is to generate absolute return. The share class is accumulating.

**Investment policy**

The fund mainly invests in long and short positions in bonds and other debt instruments listed or traded on a recognized market and are issued by credit institutions and governments in OECD countries. The fund utilises to a large extent financial derivative instruments and leverage for risk taking or hedging purposes. The gross exposure is capped at 150 times the value of net assets. The investment strategy is active. This means that there may be significant differences in the return relative to the alternative investment fund's target. The fund is categorised as article 8 under SFDR and promotes environmental and/or social characteristics, as well as good governance practices, through screening, exclusions, investment analysis and decision-making as well as active ownership. The fund follows Danske Invest's responsible investment policy. Fund shares can normally be redeemed on banking days. Recommendation: This alternative investment fund may not be appropriate for investors who plan to withdraw their money within 3 years.

**Latest fund report**

In January, Danske Invest Hedge Fixed Income Relative Value provided a return of 1.65%.

January's positive performance was driven primarily by covered bonds and agency exposures. We also recorded small positive contributions across most other investment areas, including curve trades and country spreads. Some of our protection trades also contributed with small positive returns.

Looking ahead to the year, we continue to see potential for attractive opportunities, although fewer appear as compelling as at the start of 2025. That said, we still expect to meet the return target of the risk-free rate plus 4-6% per annum.

Geopolitical uncertainties remain elevated, particularly the ongoing Russia-Ukraine conflict, which continues to draw significant attention amid persistent attacks and limited progress in peace negotiations. Other global tensions also remain in focus, including the conflict in Israel and Gaza, tensions involving China and Taiwan and the political situation in the United States.

At the end of January, the portfolio's risk level, measured by Value-at-Risk (1 week, 95%), was approximately 50% below our maximum risk limit. This represents a small increase in risk since the beginning of the month.

Historical returns are not a reliable indicator of future returns. It should be noted that monthly returns (in percent) are non-additive.

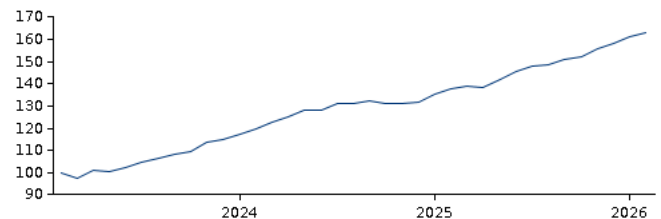

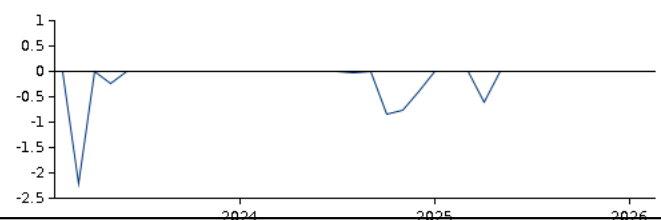


**Return in the period: 10.02.2023 - 27.02.2026**
