Investment policy

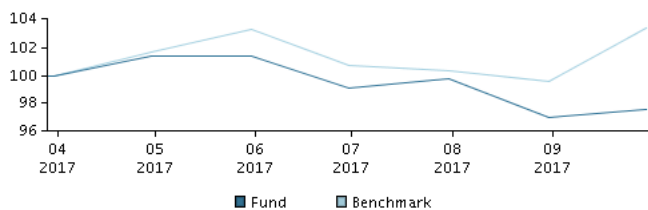
The fund invests mainly in equities in companies domiciled in, traded in or with main activity in Europe. A small part may be invested in securities issued by companies domiciled in or traded on market places in countries in Eastern Europe or bordering on Eastern Europe.

In actively managing the fund's portfolio, the management team selects securities that appear to offer superior investment characteristics.

The fund may use derivatives for hedging and efficient portfolio management.

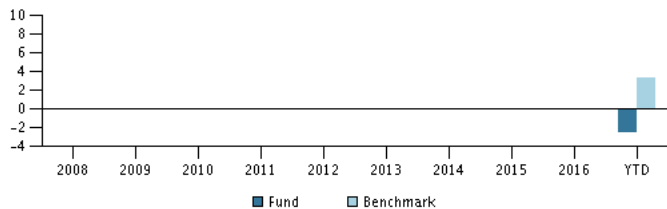
Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

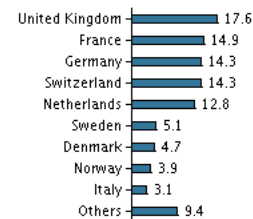

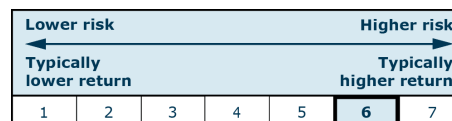
