

Objectives and investment policy

Objectives

The objective of this alternative investment fund is to generate long term returns by investing in alternative investment assets. The fund may pay out dividends, however it is not expected within the initial 5 years from the launch date.

Investment policy

The fund invests in a diversified portfolio of different types of investment assets e.g. in private equity, infrastructure, forestry, agriculture and real estate. Financial leverage is typically applied within the individual investments. The fund mainly invests in private companies and funds within the OECD countries. The investment strategy is active. This means that there may be significant differences in the return relative to the fund's target. The returns of the portfolio investments are expected to derive mainly from capital gains and to a lesser extent from dividends and interest.

Fund shares can normally be redeemed on redemption days. However, limits on redemption may be in effect. Please refer to the following section in the fund's prospectus: "Redemption of Shares".

Recommendation: This alternative investment fund may not be appropriate for investors who plan to withdraw their money within 7 years.

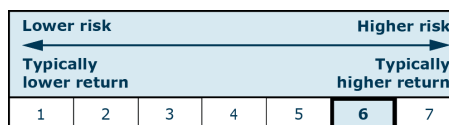

The indicator illustrates the typical correlation between the risk and your potential return of the investment.



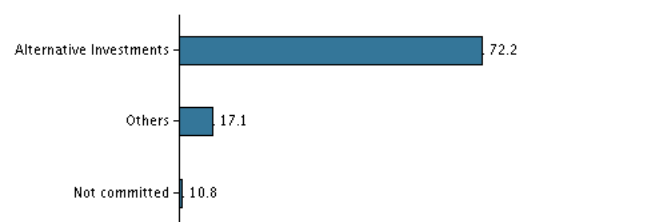
