Objectives

The objective of this fund is to achieve long-term investment growth. The share class is accumulating.

Investment policy

The fund invests in a diversified portfolio of other funds mainly invested in equities in respect to the following allocation:

At least 75% must be invested in funds investing in international equities. Up to 25% may be invested directly in equity related

transferable securities. Between 0% and 20% may be invested in funds specialized in IPOs, OTCs or private equity.

The allocation can change over time.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.
