Objectives and investment policy

Objectives

The objective of this fund is to achieve above-market performance. The share class is accumulating.

Investment policy

The fund invests mainly in equities in companies domiciled in or with major activities in Eastern Europe excluding Russia and listed on an official stock exchange. A minor part can be invested in equities in companies domiciled in countries bordering Eastern Europe.

In actively managing the fund's portfolio, the management team selects securities that appear to offer superior investment

characteristics.

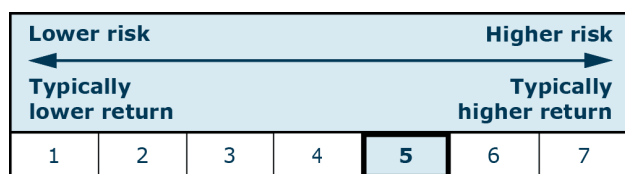
The fund may use derivatives for hedging and efficient portfolio management, as well as investment purposes.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 7 years.

Risk and reward profile

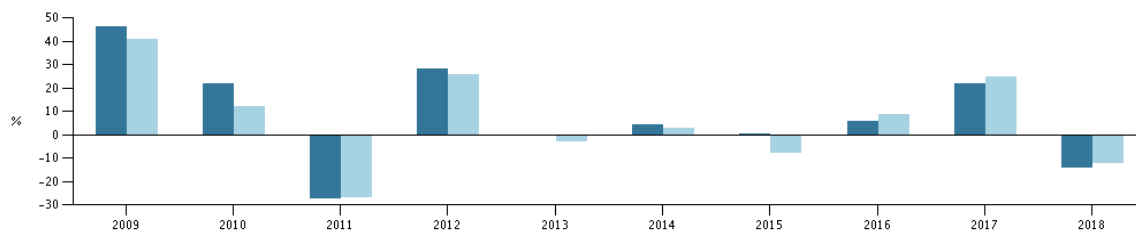
