## Objectives and investment policy

#### **Objectives**

The objective of this fund is to generate a return at least equal to the return on equities in the Balkans. The fund is accumulating.

#### Investment policy

The fund invests mainly in equities listed on different official stock exchanges in the Balkan region.

Furthermore, the fund can invest in companies with major part of their business in Balkan markets but listed on stock exchanges outside the Balkan region.

The investment strategy is active. This means that we aim to find the best investments to generate the highest possible return with due consideration to risk. The strategy implies that the investments in the portfolio may deviate from the benchmark, and that returns can be either higher or lower than the benchmark.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 7 years.
