Objectives and investment policy

Objectives

The objective of this fund is to generate a return at least equal to the return of European High Yield Bonds. The fund is accumulating.

Investment policy

The fund invests mainly in high-yield bonds, contingency and convertible bonds primarily issued by companies of the EU, OECD-countries or any other of Western or Eastern Europe, Asia, Oceania, the American countries or Africa, and denominated in Euro.

The investment strategy is active. The currency risk is limited since the

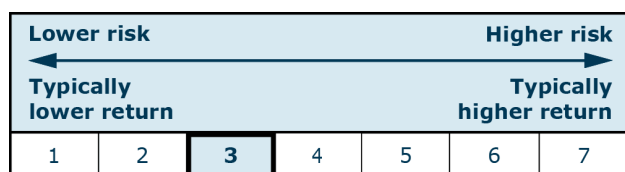
fund aims to hedge currency risks of non-euro denominated investments. The total duration of the fund, incl. cash holdings, will be the benchmark plus/minus 2 years. The fund may use financial derivative investments (such as FX forward contracts, interest rate futures contracts and Credit Default Swaps).

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Barclays Capital Euro High Yield Index, 3% issuer capped in Euro.

Risk and reward profile



The fund is categorized as 3. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

Significant historical volatility equals high risk and low volatility equals lower risk. Please note that the fund's categorization is not constant

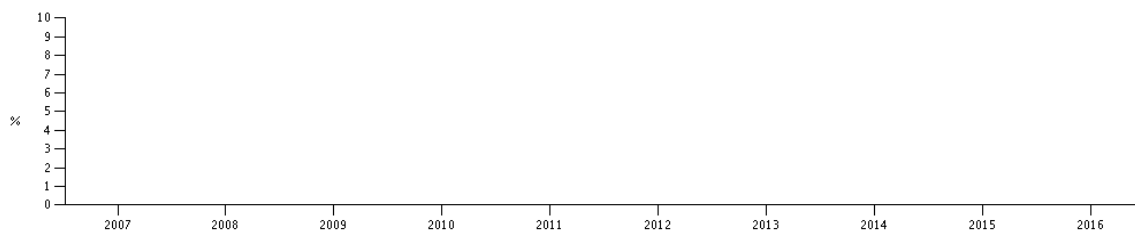
