The fund invests mainly in equities and equity related securities of companies domiciled in, or with main activity, in Germany and listed or traded on a regulated market.

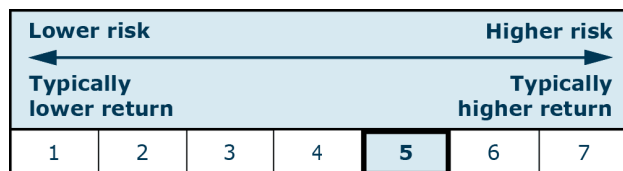

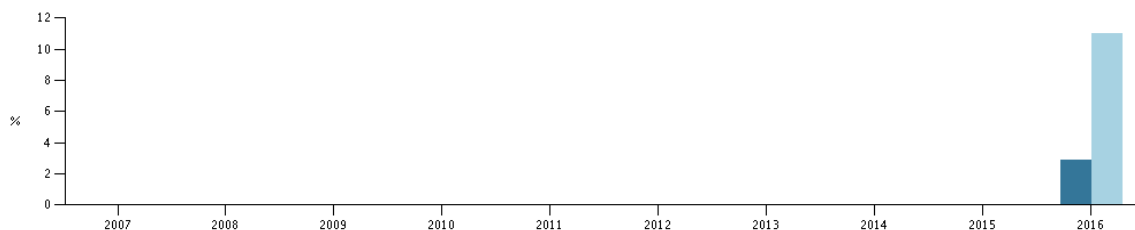
