Objectives and investment policy

Objectives

The objective of this fund is to achieve above-market performance. Dividends are normally distributed to investors each year.

Investment policy

The fund invests mainly in Swedish equities, bonds and money market instruments.

Specifically, the fund invests at least two-thirds of net assets in equities and equity-related securities, as well as corporate or government bonds and other debt instruments, that are traded on a regulated market in Sweden, or, if traded on a regulated market

elsewhere, are issued by companies that are domiciled, or do most of their business, in Sweden.

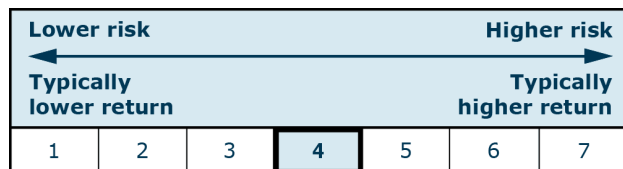
The fund may use derivatives for hedging and efficient portfolio management, as well as investment purposes.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Risk and reward profile

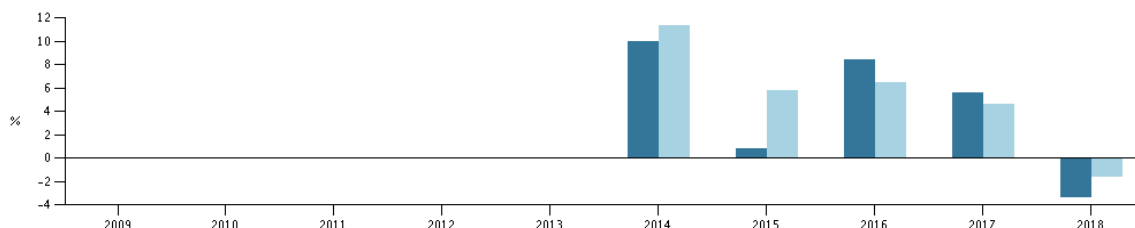
