This fund is managed by Danske Invest Management Company, part of the Danske Bank group.

Objectives and investment policy

Objectives

The objective of this fund is to achieve above-market performance. Dividends are normally distributed to investors each year.

Investment policy

The fund invests mainly in Swedish bonds that have a short duration and money market instruments from companies and credit institutions (banks) that have a sustainability profile or an improving sustainability profile. In addition to the sustainable investment policy that applies to all funds in the SICAV, this fund does not invest in companies whose revenues mainly originate from sectors such as alcohol, tobacco or pornography.

The total average modified duration, including cash, is less than 1 year.

In actively managing the fund's portfolio, the management team monitors issuers' sustainability profile and compliance with internationally recognised sustainable investment principles and engages proactively in dialogues with issuers on matters such as sustainability, strategy, finance and operations.

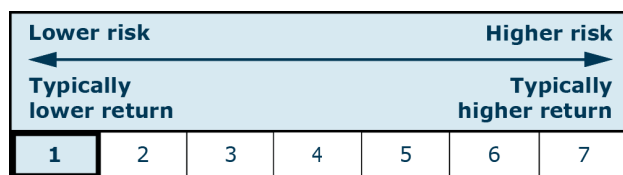
The fund may use derivatives for hedging and efficient portfolio management, as well as investment purposes.

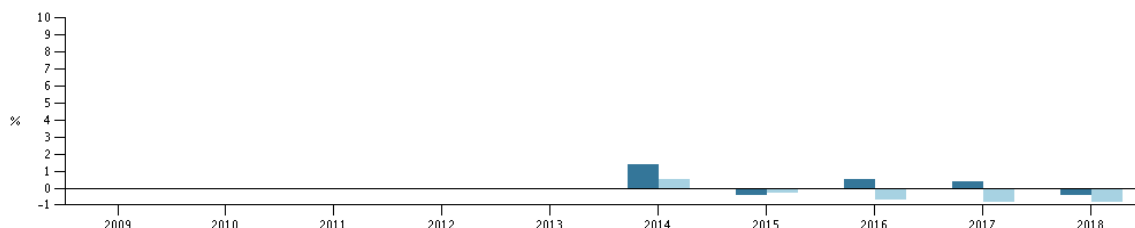
