### Objectives and investment policy

#### Objectives

The objective of this fund is to generate a return at least equal to the return on the Swedish fixed income market. Dividends are normally distributed to investors each spring.

#### Investment policy

The fund is an actively managed Swedish fixed income fund with an average modified duration between 1 and 5 years.

The fund invests in fixed income transferable securities and money

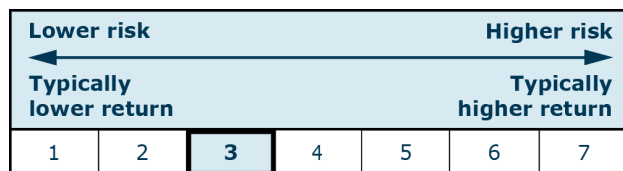
market instruments denominated in SEK. Further to the interest rate risk, which implies that the fund's return is affected by the interest rate development, the fund is also exposed to credit risks.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

### Risk and reward profile
