## Objectives and investment policy

### **Objectives**

The objective of this fund is to achieve above-market performance. The share class is accumulating.

#### Investment policy

The fund invests mainly in corporate and government inflation-linked bonds and money market instruments that are denominated in Swedish Krona (SEK).

Specifically, the fund invests at least two-thirds of net assets in bonds and other debt instruments that are traded on a regulated market and are denominated in SEK. These securities are issued or guaranteed by the Swedish government, municipalities or public organisations.

In actively managing the fund's portfolio, the management team selects securities that appear to offer superior investment characteristics. The fund generally expects that its holdings, and


