Objectives and investment policy

Objectives

The objective of this fund is to generate a return at least equal to the return on the benchmark. Dividends are normally distributed to investors each year.

Investment policy

The fund is an index tracking fund with an ethical investment policy. The fund invests in equities included in the benchmark of the fund according to ethical restrictions.

The fund is passively managed and the fund does not take any active

positions in relation to the benchmark.

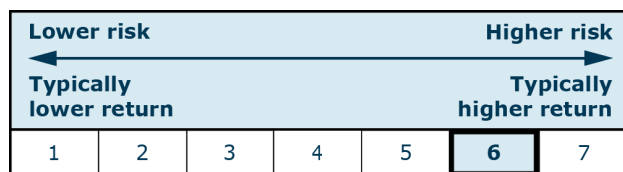
The fund may use derivatives for hedging and efficient portfolio management, as well as investment purposes.

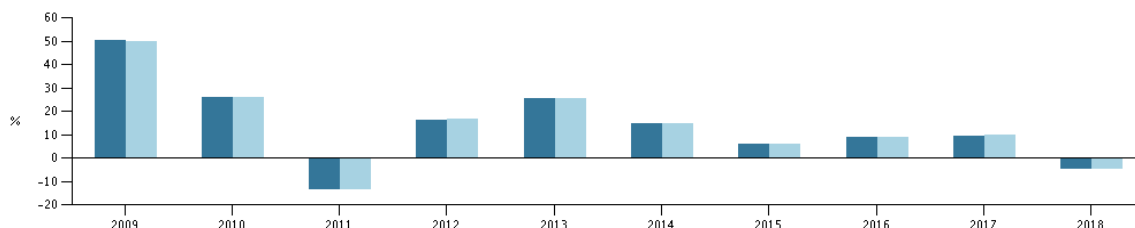
