Objectives and investment policy

Objectives

The objective of this fund is to above-market performance, while applying an opportunistic asset allocation strategy. The fund is accumulating.

Investment policy

The fund is a so-called fund-of-fund investing in other equity funds in both the Swedish and the international markets. The fund may invest up to 20% of the portfolio in equity related transferable securities. The

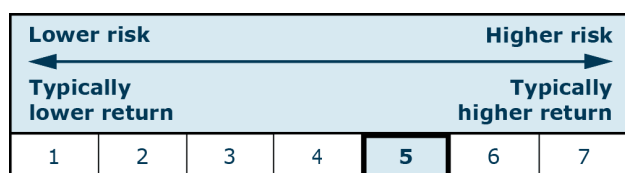
fund is actively managed and the allocation between different regions, countries and sectors may vary over time. Currency risk may occur in the fund.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

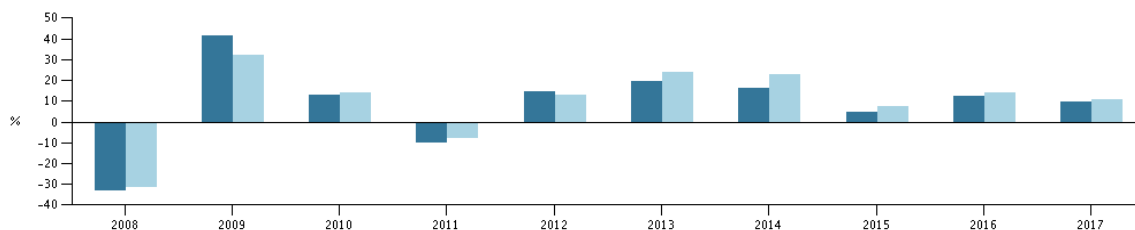
