Objectives and investment policy

Objectives

The objective of this fund is to above-market performance, while applying an balanced-to-opportunistic asset allocation strategy. Dividends are normally distributed to investors each spring.

Investment policy

The fund is a so-called fund-of-fund investing in other equity funds and fixed income funds in both the Swedish and the international markets. Investments in transferable securities and money market instruments must not exceed 20% of the total holdings.

The allocation between equities and fixed income is 70/30 as a starting

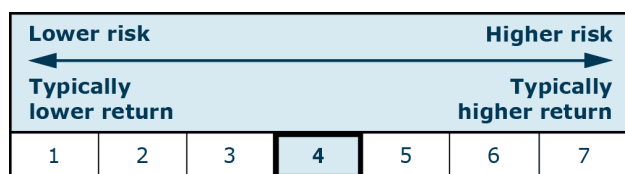
point. The fund is actively managed and the allocation between equities and fixed income may vary from the normal position. Currency risk may occur in the fund.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Risk and reward profile



The fund is categorized as 4. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.

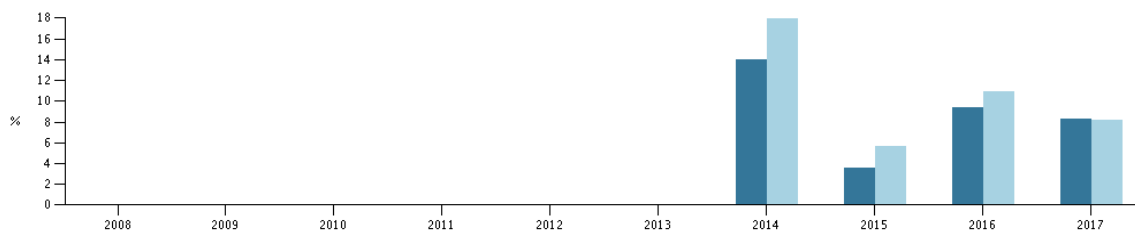
