The fund may use derivatives for hedging and efficient portfolio management.

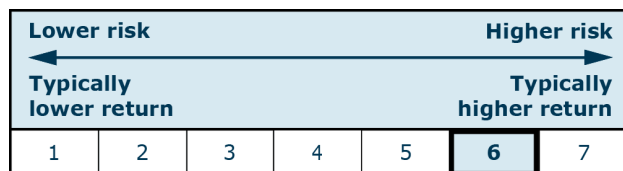

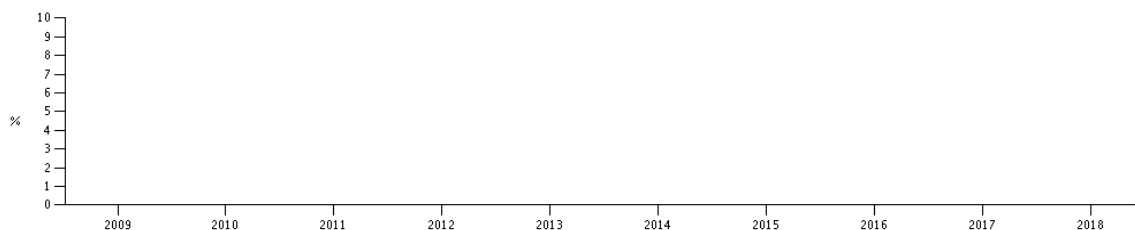
