Objectives and investment policy

Objectives

The objective of this fund is to achieve above-market performance. The share class is accumulating.

Investment policy

The fund is an actively managed equity fund investing in Swedish and international equities listed on a regulated market in Sweden. This means that the fund takes active positions in relation to the benchmark.

In actively managing the fund's portfolio, the management team

selects securities that appear to offer superior investment characteristics.

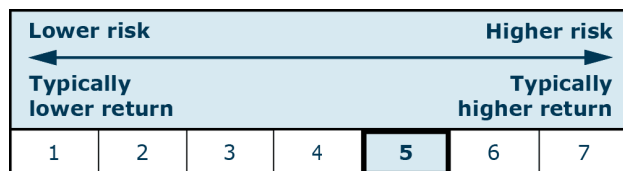
The fund may use derivatives for hedging and efficient portfolio management, as well as investment purposes.

Risk and reward profile
