Objectives and investment policy

Objectives

The objective of this fund is to achieve above-market performance. The share class is accumulating.

Investment policy

The fund invests mainly in Swedish equities with a focus on small and medium sized companies that have a sustainability profile or an improving sustainability profile. In addition to the sustainable investment policy that apply to all funds in the SICAV, this fund does not invest in companies whose revenues mainly originate from sectors such as alcohol, tobacco or pornography.

In actively managing the fund's portfolio, the management team

monitors issuers' sustainability profile and compliance with internationally recognised sustainable investment principles and engages proactively in dialogues with issuers on matters such as sustainability, strategy, finance and operations.

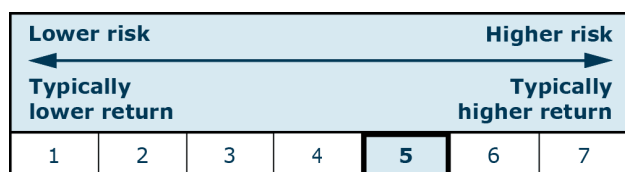
The fund may use derivatives for hedging and efficient portfolio management, as well as investment purposes.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and reward profile



The fund is categorized as 5. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.
